<u>Delegation of certain administrative services</u> - Franklin Templeton International Services S.à r.l. ("FTIS"), which is currently performing administration services for the Company, has taken a strategic decision to delegate certain administrative services to J.P. Morgan Bank Luxembourg S.A., including but not limited to preparing and maintaining accounting records, tax, financial reports, regulatory reporting and calculating the Net Asset Value of all sub-funds of the Company. FTIS will leverage J.P. Morgan's service capabilities to benefit shareholders of the Company. This change will provide a cost-effective solution that will meet ongoing regulatory needs, client demands for increasingly complex products as well as beneficial custody fee rate to the Company through scaling of J.P. Morgan's services across several funds of the Franklin Templeton group.

The appointment of JP Morgan will not have any impact on your investment and your rights or interest as a shareholder of the Company. It is not expected to trigger any change to the fee structure of the sub-funds, nor any additional costs or expenses for the shareholders. This delegation of certain administrative services does not apply to the Transfer Agency function which remains within FTIS.

The above change will take effect on 26 October 2020 and has been reflected in an updated version of the prospectus of the Company dated August 2020, a copy of which is available online or at the registered office of the Company, upon request.

#### Funds' changes:

- 1. The expected level of leverage percentage of the Franklin U.S. Low Duration Fund increased from 55% to 75%.
- 2. The investment policy of the Franklin U.S. Dollar Short-Term Money Market Fund has been enhanced in order to list additional entities that the Fund could invest in such as the United States Treasury, the U.S. Federal Reserve, the Federal Home Loan Banks (FHLB), and supranational organisations that the United States and at least one EU Member State participate in, including but not limited to the International Bank for Reconstruction and Development (IBRD or World Bank), the International Finance Corporation (IFC), and the Inter-American Development Bank (IADB).
- The investment policies of the Franklin European Total Return Fund and Franklin European Corporate Bond Fund have been enhanced to add investments in collateralised loan obligations and total return swaps on loan indices.
- 4. The investment policy of the Franklin U.S. Government Fund has been enhanced in order to (i) list additional entities that the Fund could invest in such as the United States Treasury, the U.S. Federal Reserve, the Government National Mortgage Association (GNMA), and up to 20% in both the Federal Home Loan Mortgage Corporation (Freddie Mac) and the Federal National Mortgage Association (FNMA) and (ii) permit investments in financial derivative instruments for the purpose of efficient portfolio management and interest rate hedging.
- The investment policies of the Templeton Global Income Fund and Templeton Global Smaller Companies Fund have been enhanced to add investments in futures based on equity, equity index, interest rate and currency.
- The investment policies of the Franklin Euro High Yield Fund, Franklin High Yield Fund, Franklin Strategic Income Fund, Franklin U.S. Government Fund and Franklin U.S. Low Duration Fund have been clarified to indicate that the sub-funds will have an allocation to fixed income securities of at least 75%.
- 7. The methodology used for the calculation of the Global Exposure of the sub-funds Franklin Global Multi-Asset Income Fund and Franklin U.S. Low Duration Fund was changed from a relative VaR approach to an absolute VaR approach.
- 8. The factsheets of the following sub-funds have been clarified to reflect the possibility to invest up to 50% in securities lending, as already permitted by the general part of the prospectus:
  - a) Franklin Global Fundamental Strategies Fund
  - b) Franklin Global Multi-Asset Income Fund
  - c) Franklin Global Real Estate Fund
  - d) Franklin Gold and Precious Metals Fund
  - e) Templeton Asian Smaller Companies Fund
  - f) Templeton BRIC Fund
  - g) Templeton China Fund
  - h) Templeton Emerging Markets Dynamic Income Fund
  - i) Templeton Emerging Markets Smaller Companies Fund
  - j) Templeton Global Income Fund
  - k) Templeton Global Smaller Companies Fund
- "Chinese Market risk" was added to the list of risks of the Franklin Diversified Balanced Fund, Franklin Diversified Conservative Fund and Franklin Diversified Dynamic Fund, to allow a small exposure to China Stock Connect market.



#### **Investment Management Changes:**

The following changes to the Investment Management structure of the Fund occurred during the year ended June 30, 2020:

• With effect from 2 July 2019

The management structure of Franklin Euro Government Bond Fund, Franklin Euro Short Duration Bond Fund and Franklin European Total Return Fund has changed from a single to a co-management structure. Previously managed only by Franklin Templeton Investment Management Limited, the funds are now managed by Franklin Templeton Investment Management Limited and Franklin Advisers, Inc.

With effect from 1 August 2019

Franklin Templeton Investment Management Limited was previously the investment manager of Templeton Global Climate Change Fund (previously named Templeton Global (Euro) Fund), with Franklin Templeton Investments Corp as sub-investment manager. The fund is now only managed by Franklin Templeton Investments Corp with no sub-investment manager.

The management structure of Franklin India Fund has changed from a multi to a single management structure. Previously managed by Franklin Advisers, Inc. and Templeton Asset Management Limited, it is now only managed by Templeton Asset Management Limited.

· With effect from 15 October 2019

Franklin Japan Fund was previously managed by Franklin Advisers, Inc. as investment manager, with Sumitomo Mitsui Asset Management Company Limited as sub-investment manager. It is now managed by Edinburgh Partners with no sub-investment manager.

The investment management structure of Franklin Global Aggregate Bond Fund has changed twice during the last financial year. Franklin Global Aggregate Bond Fund was managed by Franklin Templeton Investment Management Limited and Franklin Templeton Institutional, LLC. As from 2 July 2019, in addition to Franklin Templeton Investment Management Limited and Franklin Templeton Institutional, LLC, it was also managed by Franklin Advisers, Inc. as third co-investment manager. Since 15 October 2019, it is managed by Franklin Templeton Investment Management Limited and Franklin Advisers, Inc.

With effect from 18 October 2019

The management structure of Franklin Flexible Alpha Bond Fund has changed from a co-management structure with Franklin Advisers, Inc. and Franklin Templeton Institutional, LLC acting as investment managers to a single management structure with Franklin Advisers, Inc. only.

· With effect as from 2 December 2019

Templeton Global Balanced Fund was previously co-managed by Franklin Templeton Investment Australia Limited and Franklin Advisers Inc. Franklin Templeton Investment Australia Limited has been replaced by Templeton Asset Management Limited, so the fund is now managed by Franklin Advisers Inc and Templeton Asset Management Limited.

Templeton Global Equity Income Fund was previously managed by Franklin Templeton Investment Australia Limited. It is now managed by Templeton Asset Management Limited.

· With effect from 16 December 2019

Franklin NextStep Stable Growth Fund, Franklin NextStep Balanced Growth Fund and Franklin NextStep Dynamic Growth Fund were previously managed by Franklin Templeton Investments (Asia) Limited, acting as investment manager, and Franklin Advisers Inc and Franklin Templeton Investment Corp. were acting as sub-investment managers. Franklin Templeton Investment Corp. has been removed from the structure, so the funds are now managed by Franklin Templeton Investments (Asia) Limited as investment manager and Franklin Advisers Inc. as sub-investment manager.

· With effect as from 20 December 2019

Templeton Emerging Markets Fund was previously managed by Franklin Templeton Investments (Asia) Limited, as investment manager, and by Templeton Asset Management Limited as sub-investment manager. The management structure has changed to a multi-manager structure. The fund is now co-managed by Franklin Templeton Investment Management Limited and Templeton Asset Management Limited.

Franklin U.S. Government Fund was previously managed by Franklin Advisers, Inc only. Since 20 December 2019 it is co-managed by Franklin Advisers, Inc and Franklin Templeton Institutional, LLC.



With effect from 1 January 2020

The management structure of Templeton Emerging Markets Smaller Companies Fund and Templeton Asian Smaller Companies Fund has changed from a single management structure with Templeton Asset Management Limited as investment manager to a co-management structure between Templeton Asset Management Limited and the Polish branch of Franklin Templeton International Services S.à r.l.

· With effect from 27 January 2020

The investment management structure of Franklin MENA Fund has changed twice during the last financial year.

Franklin MENA Fund was previously managed by Franklin Advisers, Inc. only. As from 2 July 2019, Franklin MENA Fund was managed by Franklin Advisers, Inc., which acted as investment manager, with Franklin Templeton Investments (ME) Limited acting as sub-investment manager and since 27 January 2020, Franklin MENA Fund is only managed by Franklin Templeton Investments (ME) Limited as investment manager with no sub-investment manager.

With effect from 5 February 2020

Franklin World Perspectives Fund is now managed by Franklin Advisers, Inc., acting as investment manager, with the following sub-investment co-managers:

- Franklin Templeton Investments Corp.
- Franklin Templeton Investimentos (Brasil) Ltda.
- · Franklin Templeton Investment Management Limited
