As Shareholder of the Fund you are hereby informed that the below changes will be reflected in the prospectus of the Fund (the "Prospectus").

These amendments will not result in any changes in the fees paid, the way the compartments will be managed, nor will affect the Shareholders, the compartments' investment policy and objectives, therefore no action has to be taken. They will automatically take effect on 31 August 2023 and will be included in a prospectus to be dated in or around August 2023.

Any terms not defined in this notice shall have the same meaning as in the April 2023 addendum to the Prospectus dated 22 February 2023.

### 1. Amendments relevant to all Shareholders

1.1. Amendments made to the general part of the Prospectus

Paragraphs headed "Issue price" and "Redemption price" have been amended to clarify that the Management Company will not receive any subscription or redemption commission.

### 2. Amendments relevant to certain Shareholders

### 2.1 Money Market compartments

The reference to Pictet Asset Management Limited ("PAM Ltd") as Investment Manager of the following compartments has been removed.

> Pictet - Short-Term Money Market JPY

> Pictet - Short-Term Money Market USD

> Pictet - Sovereign Short Term Money Market EUR

> Pictet - Short-Term Money Market EUR

Further to internal re-organisation of the investment management within Pictet Asset Management, the appointment of PAM Ltd was no longer required. Pictet Asset Management SA will be the sole investment manager of the MMF Compartments.

### 2.2 Other updates of the Prospectus

The Prospectus has been updated to reflect other administrative, clarificatory, and editorial updates such as the removal of the wording related to the initial subscription period of the compartment Pictet - China Environmental Opportunities, the insertion of J share classes for the compartments Pictet - Japanese Equities Selection and Pictet - Quest Global Sustainable Equities, changes in the organisation of the Management Company, ie the composition of the conducting officers, board members, registered office and the link to the responsible investment policy and the complaints resolution procedure.
