Amendment to the investment policy of one sub-fund of Franklin Templeton Investment Funds

Dear Shareholder,

We would like to inform you that the board of directors of Franklin Templeton Investment Funds (the "Company") has decided to amend the investment policy of the Templeton Asian Growth Fund (the "Fund") to enable the investment manager to invest in securities issued by private companies.

Therefore, with effect from March 8, 2023, the following wording is added after the third paragraph of the Fund's investment policy:

"The Fund may also, in accordance with the investment restrictions, invest up to 5% of its net assets in securities issued by private companies provided that the contemplated investments qualify as transferable securities under paragraphs (1) or (2) a) of Article 41 of the Law of 17 December 2010."

As a consequence of the above, please note that the "Private Companies risk" will be added to the risk considerations of the Fund.

We would like to inform you that the board of directors of Franklin Templeton Investment Funds (the "Company") has decided to amend the investment policy of the Templeton China Fund (the "Fund") to remove the 20% limit of investments in China A-Shares.

Therefore, with effect from March 8, 2023, the fourth paragraph of the Fund's investment policy is amended as follows:

"The Fund may invest up to 20100% of its net assets in aggregate in China A-Shares (through Shanghai-Hong Kong Stock Connect, Shenzhen-Hong Kong Stock Connect, through qualified foreign investor (QFI) portfolios, UCIs and any permissible means available to the Fund under prevailing laws and regulations) and up to 20% of its net assets in China B-Shares. For the avoidance of doubt, the Fund will not invest 70% or more of its net assets in China A-Shares solely via the QFI channel."

There will be no material impact on the way the Fund is managed, its risk profile or SRRI nor on the fees charged. The new investment policy will be reflected in an updated version of the prospectus of the Company, a copy of which will be available online or at the registered office of the Company, upon request. All other features of the Fund remain the same.
