As you may know, on 12 November 2020 the President of the United States issued Executive Order 13959.

#### What does this mean?

Under this Executive Order, any "United States Person" is prohibited from purchasing for value publicly traded securities of certain Chinese companies listed by the US Treasury or Defense Department ("the Affected Chinese Companies"). This includes any instruments that are derivative of or invested in such securities. It also covers not engaging in any prohibited related activities specified in within the Order.

## When will this happen?

The prohibitions take effect from 11 January 2021.

## Does this affect me as an HSBC client?

If you are a US Person (irrespective of whether you live in another country) you must not use, directly or indirectly, HSBC products or services that involve a prohibited purchase nor engage in any prohibited related activities. You may wish to seek legal advice for specific details and we advise you to do so for your own peace of mind. This instruction only affects US Persons. If this does apply to you, it means you will no longer be able to purchase the Affected Chinese Company securities, either directly or through a third party.
